It would be difficult for me to give you any concrete advice until I have examined all your papers thoroughly, and if you wish me to do so will be pleased to have you send them here.

I would like to call your attention to the fact that there is a great deal of detail attached to a case of this kind, as well as expense, and if you desire that I examine your papers and advise you, please send all documents with a check for \$25.00 to cover initial expense. In the event that you do send your papers, I would like to know if you have any relatives in the United States because your and your wife's age may be questioned with the American Consul and an affidavit from a relative or friend will take care of this matter.
