Re: Herbert Zickhardt.

Dear Miss Razovsky:-

The above case is one of interest because of our desire to try to remove the Immigrants from our Border, and send them back into the Interior of Mexico. This young man, and a friend, Medical Students from Germany, came to Juarez, Mexico five years ago. We immediately tooks steps to send them to Monterey, Mexico, with the money we gave these boys, they reached their destination, but finding it difficult to get work, they returned to Germany. There they were arrested, and the friend of Zickhardt met his death trying to escape from the detention camp. Mr. Zickhardt succeeded in making his escape, and worked his way over on a Swiss vessell. He smuggled himself into New York, and then travelled as best he could to El Paso. Knowing that he would be reported, he took the assumed name of Joseph Deutsch.

We succeeded in getting him back into Mexico (Juarez), but he could go no farther because of the Alien registration law in Mexico, so after paying the sum of 75 pesos fine, we succeeded in getting the required registration, and with a further expenditure of \$50.00 we sent him to Mexico City. It is cases of this kind that depletes our treasury.

Would it be possible for the co-ordinated Societies to establish a fund for such emergencies?
