My dear Mrs. Zlabovsky:

The foregoing arrived in the United States as visitors on February 9, 1938

They have permission to remain in the United States until August 9, 1938. Hans' passport is valid until September 21, 1940, while Susi's passport is good until December 14, 1939.

Mr. Siegmund Emanuel, uncle of the children, is desirous of having them change their statue by going to Mexico.

He has indicated his willingness to sponsor them.

The children, who are fourteen and nineteen years of age, respectively, have their necessary birth and police certificates with them.

The uncle has an average yearly income of approximately \$4,000; has \$1,286 on deposit in a Chicago bank; and has real estate estimated at about \$30,000.

While the uncle is not a rich man, he has a comfortable home and will gladly accommodate the children in his household.

In view of the fact that Mr. Emanuel's bank account is so small and the children have no money of their own, we are wondering whether the youngsters will

have any sort of a chance with the American Consul
at Juarez.

preciate hearing from you very soon.
