

Dear Mrs. Zlabovsky:

Your letter of the 16th instant at hand today asking us to send you a detailed and complete history of the case of Luba Klebanov Kamburg. Our file in this matter runs back to January, 1928, and contains fifty or sixty letters, documents, etc., but we shall endeavor to make this letter as brief yet as full as possible.

Luba Klebanov Kamburg is the daughter of Rabbi Klebanov. He called here in January, 1928, with a letter of introduction from our Boston Office. It seems that his daughter, Luba, had applied at Riga for a preference quota visa as the minor unmarried daughter of an alien lawfully and permanently in this country. The consul did not believe that she was under 21 years of age. We took it up with our Riga Office and were advised that she appears to be much older than 21; indeed, that she had the appearance of a woman of about 35 years of age. Thereafter, it seems the father found an intended husband for his daughter, Mr. Abraham Kamburg. Mr. Kamburg filed a petition in behalf of his fiancee to obtain for her exemption from the quota, went to Riga, married her, applied to the consul, and we were advised that the consul gave her a visa but within a few days thereafter withdrew it. The consul made a report to the Department, at our cabled request, and it appeared that the consul doubted the validity of the marriage and the visa was withdrawn also on the ground of her likelihood of becoming a public charge. The matter was investigated by the authorities in this country, and it appeared that Rabbi Klebanov did not know very much about his son-in-law who is somewhat deformed and never earned much, and it was believed by the consul and our government authorities that this marriage was simply made to order"to obtain for her a non-quota visa. It also appeared that they were never married according to Jewish law, but that some kind of a Jewish ceremony may have been performed attended, however, by certain reservations, etc., etc.

We have had much correspondence with our Boston

Office, with Luba herself, her husband and her father.

It seems that she then went to Cuba thinking that she would be able to get a visa there. She would not enter into a valid Jewish religious marriage because she wanted to have that performed in this country when her father could be present, etc. I advised that a valid Jewish marriage should be performed so that there would be no question of the good faith of their marriage, and that it should also be followed by cohabitation, and that I would do nothing further in the case unless they had such valid Jewish marriage solemnized.

Long correspondence followed. On the 12th instant, we received a letter from Mrs. Luba Klebanov Kamburg from Juarez, Mexico, enclosing a Jewish marriage certificate which seems to be perfectly valid and asking our further service. We accordingly, on the same day, acknowledged her letter, told her that we were writing to the American Consul at Juarez, and we did so write to him very fully asking him to consider the case very fully, that the marriage was now beyond any question, etc., etc. We have not yet received any reply from the consul.

For your information we add the following comment:

Assuming that there is now no question of the validity of her marriage to an American citizen husband, the consul still must pass upon the question of her "likelihood of becoming public charge". Wives of American citizens are not ipso factor admissible to the United States. They are merely exempted from the quota but are, in all other respects, subject to the immigration laws. Because of the economic depression and unemployment situation in this country, the consuls are applying "likely to become public charge" very strictly. We know of hundreds of cases where alien wives or alien husbands of American citizens have been refused visas on this ground. In the case of this woman, the consul probably has no proof of the adequate means and earnings of Mrs. Frank Zlabovsky - #3 Re: Luba Klebanov Kamburg

of the husband. If his situation has not wonderfully improved since the investigation report which I read a couple of years ago, this man barely makes a living and is under a physical handicap as well.

The Department of State does not and will not issue instructions to consuls to grant visas, nor will it consider any evidence as to the financial status of the citizen husband or citizen wife. This is all solely within the province of the consul and it is he alone who must be convinced that the alien applicant is not likely to become a public charge. Many consuls are really brutal in their consideration of this question.

Supplementing our letter of the 20th instant to you:

We thought that we might save time and expedite the Luba Klebanov Kamberg matter by a request from us to the State Department that the authorization of a non-quota status be transferred to the American Consul at Juarez, and that he be so advised, instead of the Juarez Consul waiting until he receives a reply to his letter to the American Consul in Riga. We also decided first to ascertain whether the approval of her husband's petition in her behalf was still in force.

Accordingly, we looked into the matter of the husband's petition at the Department of Labor, V-87170, and find that the Department revoked the approval of this petition. A second and later petition was attempted to be filed by the husband, but this was rejected, both because a second petition is unnecessary and because the approval of the first petition had been revoked. The revocation was based upon the consul's report that he had ascertained that the marriage was arranged by her father solely for the purpose of obtaining non-quota status for Luba, that the marriage ceremony was not conducted according to the Jewish rites, and particularly, was never consummated but made with certain reservations that would enable them to disregard the marriage and consider each of them free from the obligations thereof after she arrived in this country. In connection with such revocation, a hearing was held by a Department inspector at Boston at which her father was examined very fully. The consul also reported that both she and her husband seemed "queer" and that the husband did not seem to be able to support himself much less

In order, therefore, that the consul at Juarez can consider her application for a non-quota status as the wife of ah American citizen, the revocation of his petition must be rescinded and its approval reinstated. We are willing to go before the Department's Board of Review and make the necessary application and argue same. We shall require very full and adequate proof to be submitted on the argument. We should have the certificate of the civil marriage in Riga, the Jewish marriage certificate at Riga and the Jewish mar-'riage certificate at Juarez. She recently sent us the Jewish marriage certificate at Juarez and we returned it to her. We should also have an affidavit from her giving full particulars and showing in detail whether the marriage was entered into in absolute good faith, whether they regard each other as husband and wife, whether any reservation made at the time of marriage that same should not be effected, whether they have actually cohabited as man and wife; and if possible, a certificate from a physician showing proof of cohabitation.

If Mr. Kamberg is in the United States, it is desirable that we have a similar affidavit from him, and which should also contain details of his financial status so as to show that his wife is not likely to become a public charge. It would be preferable to have him come to Washington in person with such affidavit so that we could have him appear with us before the Board of Review. It will be no easy matter to have the revocation rescinded and the approval reinstated, and we must be able to submit very strong and convincing proof.

We should add that the consul at Juarez can, of course, issue to her a quota visa and disregard her application for a non-quota status. As so many applicants under the Russian quota have been rejected or have withdrawn for the time being their visa applications, there should be no substantial waiting time for her to be reached in the quota. Perhaps you can take up this phase of the case with the consul at Juarez.

Of course, you should frankly tell the Juarez Consul all the facts in the matter. Indeed, in our letter of the 20th instant to him, we advised him fully of the facts as to the question of the marriage.

In the report of the Riga Consul, upon which the approval of the petition was revoked, he pointed out, as we wrote you, that she had applied for a visa as the child under 21 of an alien permanently lawfully admitted to this country Mrs. Frank Zlabovsky - #3 Re: Luba Klebanov Kamberg

and that she had also applied as a child under 18 of a rabbi admitted as such to this country. This woman and her father and her husband have written so many letters to us that we will be very glad to help them if everything now has been done in good faith and there is no fraud or attempted fraud in the matter. We hope that with your assistance in procuring the proof indicated above we shall be able to help her; or that you will be able, without such proof, to have the Juarez Consul grant her a quota immigration visa.

Your letters giving the history of this case were most interestin We will try to secure the affidavits as soon as possible It is hard to make these people understand the significance of our laws and with reference to Mr. Kamberg coming to Washington would only complicate mattersbecause the American Consul in Riga is reight when he says they are "queer".

I took the matter up with our American Consul as you suggested and he advised that if you can bring about a favorable decision with the Dept. of Labor and if I insist he will give Mrs. Kamberg a vise. But as Mrs. Kamberg is in Mexico only one year she comes under the Section 17 law and should the Dept. favor her appeal she would still be forced to reamin in our neighbor country another year. I often wonder if cases of this sort are worth the energy and

effort spent on them.

Dear Mrs. Zlabovsky:

Answering your recent letter in regard to the case of Luba Klebanov Kamberg, V-87170:

We have had this matter under careful consideration since you sent us the new marriage certificate, etc. Our file is exceedingly voluminous, requiring in fact preparation of a special abstract of the facts, correspondence, etc., so that it would be intelligently handled and presented. We have taken this matter up informally and unofficially in conference with officials at the Department and have not seen our way clear to make what might be a successful formal application for the reinstatement of the approval of her husband's petition for a non-quota status in her behalf.

The petition which he filed for her was approved on January 14, 1929. But this approval was subsequently revoked by the Department on August 10, 1929; the revocation being based on a report from the Consul at Riga indicating that the couple were never in fact really married and that a bona fide marriage had never been entered into by them. We thereafter had much correspondence with her and other interested parties, in which we insisted that, if they really were and intended to be husband and wife, they should have a proper marriage performed which would close all question as to the validity of their marriage. Such Jewish marriage was finally entered into at Juarez and you sent us the certificate of such marriage. This really now constitutes the first and only valid marriage between them. Hence, the revocation of the petition heretofore filed by the husband cannot be rescinded as we must more or less admit that at the time of such revocation there was no unquestioned valid marriage existing.

This leads to my conclusion and advice. On my present theory that their first and real marriage was made in Juarez, a new petition should therefore be filed by her husband in her behalf, and such new petition should be based upon and state the marriage made in Juarez. We are accordingly enclosing herewith petitions form 633 which should be executed in duplicate as per printed instructions. We do not know her husband's address and hence cannot send them to him direct. He should have these petitions correctly executed and verified by two witnesses, all according to printed instructions, and then send same to this office. We shall file them at the Department, together with proof of his American citizenship by birth in this country and proof of the marriage by the document that you have sent us. We hope that upon such petition the Department will act favorably, approve the same, and that she will thereupon be given a non-quota status and will be able to obtain a non-quota visa. In other words, our advice is that the necessary procedure to bring her to this country shall be taken by her husband now de novo, based upon the recent Juarez marriage and thus wiping out all the previous doubtful questions that had arisen.

P.S. We note from our file that the recent religious marriage was performed in Juarez, Mexico, on September 22, 1931. But we do not find that there was any civil marriage performed there. If the Mexican law (like the law of all Latin countries) requires a civil marriage and recognizes a civil marriage only as a valid one, a civil marriage between these parties will have to be performed, as the religious marriage alone at Juarez would not be a valid marriage. You can definitely ascertain what is the Mexican law as to whether a civil marriage is required. The affidavit gives very full particulars as to his absence from the United States from February, 1929, to November 5, 1930, but makes no mention of his visit or visits to Mexico. Inasmuch as the petition form 633 is based on his marriage to his wife at Juarez, Mexico. on June 16, 1932, it will be necessary that the petition show that he was in Mexico. We are, therefore, returning the petition forms herewith in order that the particulars of his visit to Mexico may be inserted therein. The petition should show, as required on Page 1, the date of his departure for Europe, date of his return, port and steamship of his return, and also the same particulars as to his visit or visits to Mexico.

We have noted also that the petition shows that his wife, Luba, lived in Russia from birth to December 23, 1929, when she went to Havana, Cuba. As she lived in Riga for a time, the dates of her residence there should be given in the petition.

We are sorry that this petition must be sent to you again for correction, but it will save time ultimately as the Department would not approve the petition unless all of these particulars are given in detail.

We very much regret to advise you that we have struck another snag in this case, and the facts are as follows;

A few days ago, Mrs. Kamberg was called before the U.S.Vice Consul, Mr. F.E.Farmsworth, at Juarez, Mexico, and he had before him the complete file on this entire matter, which file, we have since learned, was sent to him by the American Consul at Riga, at Mr. Farmsworth's request.

As a result of his questioning Mrs. Kamberg, and cross examining Mr. Kamberg, he absolutely refuses to issue a visa, and this in spite of the approval of the Department of Labor.

In taking this matter up with the American Consul at Juarez, Mexico, Mr. W.P.Blocker, who has been very kindly disposed towards all the cases which I have represented up to the present time, I learned from him that it will be impossible for them to issue this vise in Juarez, since the Consul General at Riga, especially requested them not to do so in this case, but stated to me that the entire file will this day be sent to the Department of State at Washington for their review and decision, and should the Dept. of State approve a vise, then it will be issued by the office at Juarez, Mexico.

In the course of their investigation of this case at the Consul's office at Juarez, they reached the decision that this is an L.P.C. case, despite the fact that Mr. Kamberg has tried to bring proof to bear that he has supported his wife since their marriage in Riga, in 1929, and is doing so at the present time. Mr. Kamberg is uanable to secure entry into Mexico, and is therefore forced to maintain two homes, one for his wife in Juarez, and the other for himself here. From an economic standpoint it seems this fact should be taken in consideration.

We feel that it is now up to you again, to present this case before the Department of State and we trust that you will secure some favorable action very soon. With best wishes, weare,

Dear Sirs:

My petition for a non-quota vise for my wife, Mrs. Luba Kamberg's entry into the United States, was approved by the Labor Department after a thorough investigation, and I expected this vise to be issued to her on November 6th 1932, on which date she will have completed her two years residence in Mexico.

The American Vice Consul in Ciudad Juarez, Mexico, has seen fit to also make a thorough investigation of this case, and secured from the American Consul in Riga, Latvia, the entire file, which shows discrepancies and falsifications.

In making this plea to you for your favorable consideration, I want to make the following statement; Neither my wife, or myself have at any time tried to evade or discriminate against the laws of my Country, which you will find from the records is the United States, and I am a born American Citizen.

At the time of my marriage to Luba Klebanov, in Riga, Latvia, there were many oppositions on both sides of our family, and my brothers also my wife's father made many statements that were both false and unfair to us, and our reason for not going through with a religious marriage in Riga, was due to the fact that my wife's father is a Rabbi, and since he had objected to our marriage, we had hoped that upon our reaching Boston, Mass., he would become kindly disposed, if we permitted him to perform the religious ceremony. However due to the many falsifications, and the pressure brought to bear, my wife was refused the vize in Riga, and we were religiouly married in Ciudad Juarez, Mexico, on September 22, 1931, by an ordained Rabbi from El Paso, Texas.

The American Vice Consul at Ciudad Juarez, Mexico, considers my wife's case that of a "Liable Public Charge", but I can bring proof to substantiate the fact that I have supported my wife since our marriage, and although at the present time I am compelled to maintain two homes, as I live in the United States, and my wife is forced to live in Mexico, I am still able to sustain this extra expense.

It is true that my wife's father made many efforts to have her admitted into the United States before our marriage, but we cannot see where it would reflect upon her, since she, at no time tried to evade the laws of the United States.

It is my understanding that the complete file on this case is being sent to your office for review and consideration, and I hope and pray that you will look favorably upon my petition, as it is very discouraging that I cannot have my beloved wife with me in the United States and go about my business feeling free to enjoy the fruits of our marriage in peace and contentment.



### Dear Madam:

We have thoroughly examined the file in your matter at the Department, including the last investigation report. The petition form 633 recently filed by your husband in your behalf was witnessed by Abraham Saxe and Gertrude Tabachnik. On the recent investigation, Miss Tabachnik stated that she did not know your husband, never met him, knew nothing about him, that she signed the witness' affidavit without reading it and supposed it was merely an application to bring you here on a visit, and that she did not even know you were married. For this reason, the Department has now revoked the approval of said petition, V-138210.

It also appeared from this investigation that your husband is not earning nearly the amount he stated, is not worth \$10,000, and that he has no money in any bank in his own name. His mother, who was examined at Portland, Maine, stated that she has a bank account in the name of herself and daughter, that she owns real estate in her own name which her son, Abraham, looked after, that she will probably leave it to him after she dies; but it does appear from all this investigation that your husband has no bank account in his own name, no real estate in his name, is not worth \$10,000 or any sum, and is not earning \$2,000 a year or anything like it. Your father was also questioned on this investigation, as well as other parties.

We have been receiving letters signed by you and by your husband, although both appear to be in the same handwriting. We also notice in your last letter that you give an address in El Paso. We do not know how you have entered the United
