When I came back to Chicago, I went in to see the Alderman of my ward, and I told him about bringing my brother in to the United States.

He stated he would try his best to get my brother here, and while I was there he wrote a letter to Senator Lewis of Illinois regarding same.

He received an answer that Senator Lewis is taking care of same. That is all the information I have so far.

I would appreciate you writing and telling me what further steps to take to round out the matter as quickly as possible.

Also would appreciate you doing your share down there to hurry matters along. As far as remuneration is concerned I will see that you are properly taken care of. There is no need to bother my brother about money; I am taking care of that.

Dear Mr. Fleischman:

With reference to your brother our American Consul in Juarez states that since your brother is registered in Chihuahua, Mexico, it will be necessary for the American Consul in that city to call for a number for him.

I would therefore advise that all communications such as appeals from your political friends and affidavits from yourself and brother in Chicago should be forwarded direct to the American Consul in Chihuahua, asking him for the said number and also requesting that he forward it to the American Consul in Juarez, Mexico. I will then assist your brother in getting his visa and represent him at port of entry.

Dear Madam Zlabovsky:

In reply to your communication of recent date respecting the minimum earnings required before one can properly support an alien to be admitted in this country, I wish to state that in this particular instance the relatives and friends do not earn that minimum.

It is requested in the affidavit that we make a statement showing that our minimum income for one year is \$4,000.00 for an unmarried man and \$6,000.00 for a family man.

If we were to make such an affidavit, would there be any difficulty later with the government in the event it should require the payment of an income tax on said sums so stated in the affidavit?

If you have any suggestions to make so as to help us obtain entrance of this alien, we would certainly appreciate the same.

Enclosed herewith you will find my check in the sum of \$15.00.

Dear Sir;

I wish to acknowledge your's of November 28th with check inclosed. For your information I wish to state that the affidavit will have no bearing on the income tax, as these affidavets are held in absolute confidence.

With your affidavets, if you can possibly get a letter from your congressman to appeal to the American Consul, it would go a great way. All of these communications should be sent, as stated before, to the American Consul in Chihuahua asking him to secure a number for your brother who has recently moved to Juarez, Mexico and who is engaged in business in that city. That your brother wishes to continue in business in Juarez, but that his desire is to live in El Paso, Texas for he wishes to become a citizen of the United States if the priveledge of entry is granted to him.

If there is any other way in which I can serve you, please let me know.
