The Fischer family arrived in El Paso on November 15th, and I am pleased to report that they departed for Mexico City, D. F., on November 16, 1938.

Pullman & Diner expense.....	25.00
Hotel Bill and Food while in El Paso.....	7.50

Received from your Office .....	<u>100.00</u>
Balance Due.....	\$ 7.00

Cases of this kind must be sent into Mexico first class because of their Government regulations, hence the pullman and diner expense listed above.

The El Paso Section have no funds with which to cope with cases of this kind. We are glad to assist in every way possible in contacting both American and Mexican authorities. It would expedite matters and save expense if we had a fund at our disposal.
