I am today in receipt of a letter from Mrs. Ethol Sternglanz, enclosing me copies of letters in which inquiry is made regarding Mr. Fleischman.

I have made inquiries in regard to his whereabouts and are informed this morning by Mr. Picard, President of the Jewish Aid Society of Chihuahua, that Mr. Fleischman is at present out in the country peddling. Mr. Picard also told me that this gentleman has absolutely no money and barely makes his living by peddling. Whenever he returns to Chihuahua I will make it a point to look him up and see if we cannot get him to send some money to his wife. In the meantime we can do nothing further in the matter.
