While I realize you are needed at home because of your property holdings, but we are very lonesome for you, and feel sure that Uncle and Auntie will be able to spare you for about a year.

I want you to go the American Consul in Kaunas, and ask him to please grant you the necessary documents for your entry, assuring him that you will abide by the laws of the United States, and will in no way take advantage of the privileges granted you.
