My dear Mrs. Zlabovsky:

The foregoing arrived in the United States on 4-2-37 as a visitor. He was given permission to remain in the United States until 4-30-37 and an extension of stay was requested. He has already had an examination in the immigration department here in Chicago and hopes to receive an extension within a day or two. His German passport is valud until 1-23-41.

Because of conditions in Germany of which you are already aware, Dr. Fliesser would like to change his status by going to Mexico. He has all of his documents including diplomas, etc. Dr. Fliesser was successful in securing an internship at Michael Reese Hospital for one year, ten months of which he is to receive full maintenance and two months, partial maintenance. He has practically no funds of his own, but is being sponsored by one of our philanthropists, whom we feel sure will furnish a good affidavit as well as bank account.

Do you think he stands a fair chance of obtaining a visa if we send him to you?

Your suggestions on this case will be appreciated.
