As I have already stood in touch with the German Hilfsverein, Abteilung Frankfort to come to U.S.A. but as they have failed in getting me any bail there, I take the liberty to apply to your kindness to help me in getting any bail there for me to come to America. Because I chance to have an Aunt in El Paso, but who is not in good conditions it would be certainly easy for you to come in touch with her and to find at the same time a man who would bail for me in the name of my Aunt, as you know that the people who bail, have to be relatives. The German Hilfsverein has already been informed about this plan, but cannot do anything from here. So it would be you who could be of any help to me. Concerning my career, I have started as an ironmonger and merchant afterwards I have changed my profession and became a trained butler and waiter, so that I could fill any of the positions. I, too master English and German.

Hoping that you will favour me with your valuable and great help that you will lend an ear to my prayers.
