Under separate cover I am returning the package you so kindly sent. While I appreciate the spirit in back of the gift, I think I mentioned to you when here that I am not permitted to receive gifts for my work in Juarez, Mexico.

Since you are so anxious to show your appreciation for the service rendered you by this Organization, the Immigration Department would appreciate a gift in money because they have a colony of Jewish Immigrants in Juarez, Mexico whom they maintain, giving the children, 20 in number, educational privileges in addition to clothes and food. All of this requires money and it would indeed be gratifying both to you and myself if you could assist in this worthy cause. You may make a check payable to El Paso Section, National Council of Jewish Women, and if sent to me, I will see that it gets into the proper hands.
