

Dear Madam:

I, Solomon Sheinfeld, of Russian nationality and Jewish religion, very poor financially, married and with four minor children, when my oldest child, William, which was born in New York and raised in Mexico City, reached the age of 19 years he decided to go to the United States in order that he could look for work and be able to help his poor parents.

Unfortunately, he was taken sick on the way and for more than a year now has been very ill at the Delaware State Hospital at Farnhurst, Del. He has been very well treated there but his recovery has been much retarded due to the fact that he is depressed and lonely and longs for his parents.

Dear Mrs. Zlabovsky, I appeal to your kindness to be pitiful to me and my unhappy child and put up some bond for me at the American immigration office in El Paso so that they will permit my entrance into the United States in order that I may go to my son to see what I can do for him to save his life.



I hope to be able to take him to specialists in New York. Good doctors have told me that they believe he can get well if the can see a specialist. His mother and I are greatly distressed and we pray God to turn your good will toward us to help us save our son's life. However, in case it is not in your power to do such a thing, then I beg you to please see all Jewish Societies in El Paso, Texas, and get all of you together and do this great favor for us, as his poor mother got very sick from worrying and she could not stand it any more. I would be very thankful to you if you can send down some of your people to see me and by making a true investigation you will easily find that such help is really needed. This is the first time in my life I have to ask for charity in order to save my child's life.

Should you decide to send some of your people to see me, then please let me know at once so I will send you my address in Ciudad Juarez, Chih., where they can see me.

We will be very grateful for any consideration which you may give this petition and will greatly appreciate an early reply.
