The foregoing are here as visitors and would like to change their status before the expiration of their visitor visa. However, we have applied for an extension in case you are unable to complete this matter by that time.

We are gathering up the necessary affidavits of support and the documents will really make a nice showing. They have about \$600.00 of their own in cash, jewelry (mostly diamonds) evaluated at \$1,735.00. They also have a new camera valued at about \$180.00. The close relatives making affidavits are in very good circumstances.
