Simon Kahn, being duly sworn, upon oath, deposes and says that he is a Citizen of the United States, having been naturalized by the United States District Court at El Paso, Texas, on the 4th day of April, 1921, Certificate Number 1547117, Petition, Volume 5, No. 1749, and that his occupation is Manufacturing Baker, dealing in Wholesale and Retail Bakery Products, with principal plant and office at 918 North Oregon Street, in the City of El Paso, Texas, and that he resides at 1315 Cincinnati Street, in the City of El Paso, Texas, and has been a resident of El Paso, Texas for the past 19 years, and that he is 43 years of age, is married, has a wife and four children.

That the following named aliens are about to make application for admission into the United States, at the United States Consulate in Warsaw, Poland, and that they are related to this affiant as follows:

That, Grana Behenstein, age 46, and her husband Mordecai Behenstein, age 46, are sister and brother-in-law respectively of this affiant, and their children, Paic, age 20 and Rosa, age 18, are the nieces of this affiant, and that Isaac, age 17, and Joseph, age 10, are the nephews of this affiant;

That all of the above named aliens now reside at, Zamkova Street No. 14 H. B., in the City of Grodno, Poland;

That this affiant is ready and willing to care for the above named aliens, when they are admitted to the United States;

That this affiant is able to care for the said aliens, because the value of the property owned by this affiant is \$ 90,000.00, and that there is no incumbrance of any kind whatsoever thereon, and that his net income annually is \$ 10,000.00; that this affiant has only his wife and four children depending upon him, and that he will be only too happy to assist the above named aliens financially whenever necessary;

That this affiant has never been called upon to contribute anything toward the support of the above named aliens; that the said aliens have never needed any financial assistance from the affiant, so far as this affiant knows;

That this affidavit is made to support the assumption that the aliens above named will not become a public charge.
