CURRICULUM VITAE

I, the undersigned, Susi Kaufmann, was born on March 12, 1915, as daughter of the merchant, Carl Kaufmann, in Stettin. I visited the Realgymnasium (Secondary School for Classical and Modern Languages) for Girls of the Kaiserin Auguste Victoria School until Oberprima (highest grade), and in the summer of 1933 I went to England in order to study the language. After a stay of one year at the University of London, I passed the Matriculation Examination. After my return to Germany I passed the English Interpreter Examination, and took a course in typewriting and stenography and visited the Municipal Trade School for Women in order to perfect my knowledge in cooking and baking.

On September 1, 1935 I started to participate in a course of Mensendiek-Gymnastics which I continued during my whole stay in Berlin. From October 1, 1935 I visited the Massage School of Dr. Franz Kirchberg of Berlin. The training course in massage and orthopedic gymnastics takes half a year. After the absolution of the State Examination I was engaged in the hydro-therapeutic and electro-therapeutic Department of the Jewish Hospital in Berlin. Thereafter, I acquired a special training in gymnastics for babies and infants under the direction of Major Neumann-Neurode of Berlin, and participated in a training course of orthopedic gymnastics-including creeping treatment of Professor Klapp. The practical part of the training was directed by the state licensed orthopedic gymnastic teacher, Charlotte Elias, while the theoretical part was conducted by Dr. med. Erich Löwenthal who gave instructions in Anatomy and Physiology as well as in the Pathology of orthopedic diseases. At the same time I was employed for some months in the orthopedic department of the Jewish Pediatric Hospital (under Professor Glässner) where I trained the children in gymnastics and massaged them. Since March 1, 1937 I am working in the Out-Patients' Clinic of the Jewish Congregation of Berlin.
