At your request, we visited Mrs. Tankenoff. She advises us there is no reason for her mother to be distressed about her health, as she writes her mother regularly. She informs us that she believes the basis of her mother's worry is the fact that after the little boy, Sidney, was born, an immediate operation was necessary which was not made, and the accumulation has resulted in a tumor.

Mrs. Tankenoff, however, has been receiving medical treatment at the Ancker Dispensary here, and is feeling fine.
