Mr. Bloom or Butler is living in Silver City New Mex. He got a divorce from his wife in California on the grounds of adultery and is now married to a former Elempso girl and is living in the above named city.

The report on Mrs. Bloom of Los Angeles is as follows:

Mr. Bloom was her third venture in matridamy. Her first child whom we understand is a cripple is by a former marriage ans when Mr. Bloom moved to Los Angeles with his wife and children Mrs. Bloom became enamoured with a young man and forced her husband to leave.

How true this information is I do not know but such is the history of the case as told to me by the family in El Paso.
