We are pleased to acknowledge receipt of your letter of July 13 requesting our intervention in behalf of your parents, Abraham and Frymit Weissberg, who reside in Mexico and who desire to visit you in the United States. It appears that the visa applications have been referred to the Interdepartmental Visa Review Committee for consideration.

We shall be gled to represent their applications before said Committee.

Please inform us also as to the nature of your father's business. It is noted that your husband last saw your parents in March, 1942. Was he then in Mexico?

Please advise us as to the nature of your mother's illness in order that we may be prepared to answer any question on this point.

Upon receipt of the foregoing information, we shall be able to prepare this case for presentation to the Committee.
