Dear Miss Razovsky:-

Yesterday I received and turned over to Mrs. Mayer the sum of \$100.00. That will not be sufficient for Mrs. Mayer's stay in Mexico City, and will ask you to send her another \$50.00 (Hotel Geneve, Mexico City (by air mail)).

Mr. Wortman came to Juarez, Mexico yesterday morning which complicated matters but we succeeded in sending the couple by car to Chihuahua, Mexico. There Mrs. Mayer will pick them up this evening and continue the trip to Mexico City.

If you have not as yet sent the papers, please do so immediately by airmail to Mrs. Mayer to the above mentioned hotel, and I am sure that she will represent the case to the Consul General, we hope with favorable results.

Dear Mrs. Mayer:-

I just heard that you left on a business trip to Mexico City, and while there I would like you to meet Mr. and Mrs. Lothor Wortman & Maria Ascencio, Bucarelli 53, Mexico D. F. Their relatives in New York are friends of Herman (my son-in-law)

From the correspondence I received I judge they are a most deserving and worthwhile couple for future entrance into the United States. They are German refugees and have no place that they can call home because of religious and political persecution in Germany. From what I understand of their case they had entered the United States illegally, not because they wanted to break any law of our Country, but because they had no place to go. When apprehended, they were given and accepted voluntary departure. They are now in Mexico on a temporary visit and have applied to the Department of Labor for permission to apply for permanent entry into the United States.

I am going to ask you to please present their case to the American Consul-General, asking for favorable recognition of their application, feeling sure that this couple will make most desirable citizens of the United States, if given a chance.

I enclose herein copy of a statement which the American Consul gave to the Wortmans in Mexico City, also a statement showing what additional documents are required from you in order to enable the Wortmans to get their visas. I do hope it will be possible to get aid to these unfortunate people. They can be reached General Delivery D.F., Mexico City, Mexico.

They are writing to Germany, Italy and Roumania for their police certificates, they also must have their marriage certificate. They will have to wait quite sometime until these papers reach them. It is too bad that during this whole year they did not get these documents together.

According to a report received from our friend in El Paso, who assisted them, they are living on next to nothing, saving every penny in order not to be stranded.

Mrs. Mayer just told me about your letter with enclosure with reference to the Wortmans.

After their departure for Mexico (Juarez) I questioned them about their papers and Mrs. Wortman made the statement that many of their papers were sent to Washington at the time of their apprehension. Do you know anything about it?

Their bond expires in September and they will have to leave Mexico or forfeit the bond. It will be necessary, therefore, for them to get their papers at the earliest possible moment. Is there anything you can do to expedite matters?
