Dear Mrs. Zlabovsky:-

A mutual friend of ours, a Mrs. Lefkowitz of this city, has told me of the excellent work you have been doing in aiding those who have relatives in Germany by hastening their obtaining a visa in order to come to the United States.

My wife has a married sister and child living in Berlin, Germany, and we have attempted for the past  $2\frac{1}{2}$  years to bring them over to the United States in order to escape the Hell in which they are now living. The names of our relatives are Alois-Oswald Hausmann, wife, Frieda, daughter Loloa. He has been a very successful business man until the Hitler regime came along, since which time he has lost his business and is unable to do anything. His wife, Mrs. Mandell's sister, is ill and in need of medical attention which she is unable to get.

I have tried to get them over here and have sent all possible information and affidavits and letters of recommendation from substantial citizens in Houston in order to induce the American consul in Berlin to grant the visa . All of which has been of no avail.

If there is anything which you can do to aid us in bringing these unfortunate people over here our gratitude would be immeasurable. Should you desire to go further into the matter I would be only too glad to mail you all of my file, showing you the duplicates of affidavits, letters of recommendation, financial statements, etc., that have been heretofore forwarded to the American Consul in Germany. #2. We would certainly appreciate very much if you would let us know what, if anything, you can do to aid us in this matter. My wife is, of course, greatly con-cerned about her relatives and their wellbeing, and her worry over them has, and still is, affecting her health.

Your kind attention to this matter would be highly appreciated by all of us.
