Dear Miss Razovsky;

Not being able to get the information required from you, we wired to Joe Joseph, 521 Broadway, New York City, and he wired in return stating that the above arrived in New York, on The Martha Washington, Aug. 2, 1909. The Government accepted that information pending thier investigation and permitted Mrs. Matza to proceed on her journey.

The Immigration dept. is as unsuccessful as yourself in verifying this statement and will therefore ask you at the present time to get in touch with the above mentioned Joe Joseph and furnish me as soon as possible with her present address in Los Angeles.


My dear Mrs. Zlabovsky:



Martha Washington in June or August, 1909, he secured from Mr. Louis Moses, 54 South 10th Street, Brooklyn, N.Y., who states that he arrived on the same steamer with Mrs. Matza and that this is the steamer. We feel certain that the woman belongs in this country legally.

She has a daughter, Mrs. Betty Solomon, 1561 Walton Avenue, Bronx, N. Y.
