

Biography or Historical Sketch

Born in Lordsburg, New Mexico on April 6, 1895, Laurence Edwin Stevens (1895) – 1969) moved to El Paso with his family around 1897. Stevens was the son of Charles B. and Emma Stevens and the family resided at 215 W. Yandell Boulevard for many years. A prominent El Paso businessman, Stevens was involved in the family real estate business along with his father and uncle, Horace B. Stevens, and later had farming interests in El Paso's Upper Valley. Laurence Stevens attended school in El Paso and later at Lawrenceville School in New Jersey and at Cornell University. During WWI he served as a captain of infantry. After WWI ended Stevens returned to El Paso and entered into his family's real estate business. In 1921 Laurence Stevens married Frances Smith (1895 – 1979), daughter of Congressman William Robert Smith of Texas. Frances Stevens worked as an administrative assistant and secretary to the first ten presidents of the College of Mines (later Texas Western College and University of Texas at El Paso) until her retirement in 1961. The Stevens also raised two nieces in their home. A noted authority on El Paso, Stevens was a member of the Board of Directors for the El Paso County Historical Society, and both Laurence and Frances Stevens served on various committees for that organization. Stevens also held the post of U.S. jury commissioner of El Paso from 1927 – 1965, served as vice-president of the Pioneer Association of El Paso, and was a member of Phi Delta Theta Alumni Association. The Stevens later lived at 917 McKelligon Drive in El Paso.

Scope and Content Notes

The Laurence E. Stevens papers date 1880s – 1990s, bulk 1910 – 1962. Types of records include correspondence, clippings, publications and other printed material, field notes, real estate records, souvenirs, memorabilia, and photographs. Arranged in five series (El Paso history and souvenirs, Real estate and legal material, Maps, Photographs, and Publications), these papers primarily document late nineteenth-century and early twentieth-century El Paso and Stevens' real estate and business activities.

The El Paso history and souvenirs series contains souvenir books and booklets about El Paso, various memorabilia, clippings, and a transcript of a program sponsored by the El Paso County Historical Society about El Pasoan's recollections of the Mexican Revolution. The Real estate and legal material series includes correspondence, field notes, mineral surveys, affidavits, and other property records connected to Stevens' career in the real estate business. The Maps series consists of maps of El Paso, New Mexico, and sectional aeronautical charts of several southwestern cities. The Photographs series contains several possible Stevens' family photographs and assorted scenes of El Paso. The Publications series includes several publications about New Mexico, El Paso, and Texas and a random clipping of a bear from an unidentified magazine. Also of note are publications regarding the use of hydro-electric power from Elephant Butte and Supreme Court cases between Texas and New Mexico over their shared boundary.
