Baby Please Insure My Car

Throughout the United States, and much of the global economy, some of the most vexing issues faced by many involve automobile insurance. Car insurance represents a major financial concern for households, companies, public agencies, and non-governmental organizations. It causes further difficulties in the Borderplex where drivers frequently cross the international boundary without obtaining coverage for the country being visited.

As most parents will readily agree, car insurance is expensive. That is not a recent development. U.S. Bureau of Labor Statistics data indicate that, during the past half century, annual changes in the price of automobile insurance almost always outpace general consumer price inflation by 100 basis points or more. What causes car insurance rates to rise so much?

An important source of auto coverage annual rate hikes will come as no surprise. Health care costs also tend to increase at fairly rapid clip. As the price of medical care moves upwards, car insurance also rises. Hospital and therapy bills for injuries suffered in road accidents already average more than \$20,000 per accident, and they are becoming more expensive.


Replacement costs for totaled vehicles are also escalating. New car and truck prices have increased by roughly 10 percent over the last 12 months, while used vehicle prices have also jumped. Automobile accidents also generate higher repair bills for vehicles that can be made road worthy, again. Sheet metals, electronic chips, and other components have all increased substantially due to global supply disruptions.

Beyond physical material and medical service prices, legal costs have also increased in recent years. Television and internet advertising campaigns indicate that many wrecks are adjudicated through the court system.


Those high stake negotiations and court battles are expensive endeavors and ultimately affect automobile insurance costs and rates.

Car insurance is, understandably, becoming more expensive. Can drivers do anything to lower automobile insurance costs? That topic will be examined in a future issue of the **Barometer**.






El Paso County SNAP (Food Stamp) Enrollment




Pharmaceutical Nominal Price Ratio in the USA and Mexico



Personal Vehicle International Bridge Crossings to El Paso

















Total Trade through the El Paso Customs District






Domestic Passengers Ciudad Juarez International Airport




Domestic Passengers Chihuahua City International Airport







