## Biography

James E. Hyslop was born in England on November 7, 1865 and came to Hidalgo del Parral, Chihuahua, around the turn of the century as General Manager for the London-based mining firm of San Francisco del Oro, Ltd.

In 1903 Mr. Hyslop married the daughter of William Beckmann, another prominent mining engineer with extensive holdings in the Parral district, and proceeded to acquire properties in Mexico including the Hacienda de Santiago. While living at the hacienda, Hyslop continued as General Manager of the San Francisco del Oro mines.

According to George Griggs, in his book *Mines of Chihuahua*, the adjacent mining districts of San Francisco del Oro and Santa Barbara are the oldest and richest in the Mexico, dating at least from 1556, with silver being the principal ore extracted from these mines.

## Series Description or Arrangement

These papers are minimally processed. Materials fall into three areas: Hacienda Activities, Mining Activities, and Family Activities, with sub-series of Financial and Correspondence in all series and publications under the first two series. If the collection is fully processed, the bulk of the material will be in the Hacienda and Mining activities series. In addition to the three main series there is a small quantity of photographs that will likely be a fourth series.

## Scope and Content Note

The Hyslop-Beckmann family papers, MS 211, date 1896-1938 and are housed in four boxes (12" x 12" x 16"). These papers reflect James Hyslop's mining and hacienda activities from about 1900 to 1931. Receipts for El Paso businesses are also included.
