### **Historical Sketch**

Formed in 1983, Alert Citizens for Environmental Safety (ACES) was a nonprofit organization that researched, educated and provided information to communities in Hudspeth County, which would be affected by the construction of a low-level radioactive waste dump. During the 1990s, ACES' stated goals were the prevention of such a dump, and the establishment of long-term protection of the area's natural resources, in particular groundwater.

Aside from the nuclear waste threat, between 1992 and 2001, a Long Island, New York company called Merco Joint Venture, brought from New York as many as 45 train cars per day of sludge from New York City into their 129,000-acre West Texas property. The scale and scope of these projects represented a threat to the health of area residents due to water and air contamination.

ACES was directed by Roy Griffin, Sandra Griffin, and Linda Lynch who were dedicated for many years in collecting information on toxic waste from various government and non-government sources. They analyzed the information and provided literature based upon their findings to the public. The group also compiled information specific to West Texas projects. ACES membership was comprised of farmers, ranchers, town merchants, and families who were opposed to land burial and incineration of toxic materials as a disposal method.

ACES used information from various industries, information from environmental activist groups, federal resources, such as the Nuclear Regulatory Commission, and state resources, such as the Texas Low-Level Radioactive Waste Disposal Authority. ACES also used UTEP Geology Department reports and government documents. The information collected was disseminated to the public through meetings and seminars and by other organizations.

The anti-nuclear waste dumping campaigns of the Hudspeth County residents and other organizations, including ones from Mexico, against Merco Joint Venture were successful, and nuclear waste dumping in Sierra Blanca, Texas, near the Rio Grande, ceased. ACES' successful fight is seen as a historical victory in Environmental Justice case studies.

The records were left in the order found by archivist (original order, primarily alphabetical).

## **Scope and Content Notes**

The ACES records date 1989 to 1998, bulk 1992-1994. The documents were left in original order. The records contain information about ACES members who played key roles in the fight against nuclear waste and environmental organizations. The records contain newspaper clippings, cartoons used in the press, faxes between other environmental organizations, publications, court cases, legislative papers, and extensive information about nuclear waste and sludge waste pollution.
