Historical Sketch

The National Health Planning and Resources Development Act of 1974 authorized a network of health systems agencies throughout the country to address health care problems at the local level. Structured as a public regional planning body within the West Texas Council of Governments, the West Texas Health Systems Agency was one of 12 such bodies in the state of Texas. WTHSA was governed by residents of the 6 counties it serves. Members presided on a voluntary basis, assisted by a small paid staff. Agency activities were grouped into major interest areas served by committees. The WTHSA provided community groups and health organizations assistance through grant writing, needs assessment and program development, staff training, and data collection and analysis. It also helped groups identify sources of funding, and disseminated information on health care regulations.

Arrangement

Records are arranged alphabetically by subject.

Scope and Content Notes

The collection consists primarily of material detailing the operations of the West Texas Council of Governments and the West Texas Health Systems Agency, mostly in the form of reports and proceedings. Also included are health-related books, monographs, and journals. The collection is an important source of information on the delivery of health care in West Texas during the period 1974-1983.

The West Texas Council of Government donated 52 boxes of printed material from its offices to the University of Texas at El Paso Library in June 1983.
