Biography

James Jay Kaster V (1933- 2005), a Democrat, was El Paso County's representative to the Texas Legislature from 1971-1977. Kaster was born in El Paso, served in the U.S. Navy during the Korean War, and graduated from Texas Western College (now UTEP) with a BBA in 1957. After four terms in the state legislature, Kaster became El Paso County's Tax Assessor-Collector. From 1979-1983, and in 1987, he served as the Legislative Liaison for Governor William P. Clements. Kaster also served on the Industrial Accidents Board and was chair of the Texas Employment Commission.

In addition to his political career, Kaster was a past president of El Paso's and Austin's Lions Clubs and served on the McDonald Observatory Board of Visitors for over 20 years. He received several awards for his work with the Lions Club and was awarded UTEP's Gold Nugget Award in 1988.

He was married to Helene Kaster and they had six children.
