Biography

Henry Gordon Frost was an El Paso teacher, author, and former president of the El Paso County Historical Society. He is best known as the author of *The Gentlemen's Club* and co-author with John H. Jenkins of *I'm Frank Hamer, The Story of a Texas Peace Officer.* He collected guns, knives, and old documents, according to El Paso historian Leon Metz. Frost committed suicide in Michigan in 1987.

Series Description or Arrangement

Materials were left in the order found by the archivist.

Scope and Content Notes

Consists chiefly of records concerning the 34th Judicial District Court of El Paso County, El Paso, Texas. Materials include writs, briefs, correspondence, receipts, subpoenas, and other court-related documents. Also included are property deeds and mining claims. Some of the materials are in Spanish.

Some folders and envelopes are empty. Most of the documents are in poor condition.
