#### **Historical Sketch**

Founded in the early 1990s by El Paso attorneys and human rights activists, the Border Rights Coalition is a human rights organization based in El Paso, Texas. The Coalition later changed its name to the Border Network for Human Rights. Its objective is to promote and defend human rights in the border region by documenting "alleged human rights and civil rights abuses committed by the Border Patrol and provided legal aid to the community on specific cases." The first coordinator of the group was Suzan Kern.

The Border Rights Coalition was involved in the 1992 civil federal lawsuit brought by Bowie High School staff and students "to stop the Border Patrol from harassing students inside the school." Another one of the organization's most publicized efforts was its involvement in the case of Esequiel Hernández, Jr. – a Mexican-American teenager who was killed by Marines patrolling the border near Redford, Texas in 1997. In 1998, with the hiring of Fernando Garcia as executive chief of the Border Rights Coalition, the group became more of a grassroots organization. During the mid-2000s, the Border Network for Human Rights focused on immigration reform.

Consists of correspondence, publications, reports, videos, and other items.
