## Historical Sketch

El Paso County was first established in 1850 and the county's largest town, San Elizario, served as its first seat. Later, the county seat was moved to Ysleta and then finally to El Paso in 1883. County clerks of varying abilities and qualifications managed the county records during the nineteenth century. During the U.S. Civil War, the records were lost though the deed records were recovered. Some former county clerks during the early twentieth century include Park W. Pitman, W.D. Greet, and Eleanor Love Greet.

The records were originally stored in rented rooms and in clerks' homes and then in courthouses in Ysleta and El Paso. Some of the records stored in El Paso's courthouse may have been lost or damaged when a fire broke out in 1890. County records were also stored in people's basements and attics as well as the old jail in El Paso. The poor condition of some of the records reflects this storage history.

In 1975, the Texas State Library and Archives Commission transferred the county records to the UTEP Library as part of its newly formed Regional Historical Resources Depository program. Through the program, the Texas State Library retains ownership of the records, but allows the records to be housed and made available to researchers at the UTEP Library.

Files are somewhat listed in case number order. Files were left in the order found by the archivist.

## Scope and Content Notes

The "Old Civil Cases" are local governmental records housed in Special Collections as part of the Texas Regional Historical Resources Depository program. These files date 1866 – 1918 and are listed as "Old Civil Cases, County Court" on page 27 of the master guide to the El Paso County records, MS132, created by Laura Hollingsed in 2005. Information in the files includes the case number, the name of the court case, and date, though some files are missing information and there are sometimes gaps in the case number files.
