SUMMARY: Stovall is a native of Durant, Okla., born there in 1914. At age five, he and his family moved to Mineral Wells, Tx., where at age 18, in 1933, he enlisted in the Civilian Conservation Corps. His first six months in the CCC were spent at Lampasas, Tx. In January 1934, his 200-man company was transferred to Big Bend.

Stovall recalls that his company was the first stationed at the Chisos Basin in what is now Big Bend National Park, although a temporary dirt road to basin had already been constructed and several structures had been built for CCC use. Stovall lived in a tent camp at the basin, where he worked as a cook. He eventually became "first cook" at the Chisos camp, earning \$45 a month. Stovall's duties as a cook kept him confined largely to the Chisos Basin camp, yet he provides a perspective on the role the CCC played both in the park and in the lives of individuals who served in the corps.

He recalls a cadre of regular U.S. Army officers in charge of the camp. He remembers three CCC members getting lost for three days while hiking. He recalls seeing NO wildlife in the Basin in 1934 (he said he saw more wildlife when he returned to the park for the first time in 1992).

Stovall's duties as a cook kept him confined largely to the Chisos Basin camp, yet he provides a perspective on the role the CCC played both in the park and in the lives of individuals who served in the corps.
